



FIFTY FOR FIFTIETH ANNIVERSARY PROMOTION
SPONSORED BY CARMINE'S PIZZA KITCHEN

OFFICIAL RULES

The Fifty for Fiftieth Anniversary Promotion (the "Promotion") is open to all legal residents of the United States who are eighteen (18) years of age or older. Void where prohibited by law. Individuals employed by Raiders Way LLC d|b|a Carmine's Pizza Kitchen ("Sponsor"), or their respective affiliates and subsidiaries, or their advertising and marketing agencies; and such employees' immediate families, may not enter or participate in the Promotion. Immediate family members are defined as a parent, spouse, sibling, child or anyone sharing the same residence as the applicable employee. By participating, entrants agree to be bound by these Official Rules as may be modified or amended by Sponsor, and the decisions of the Sponsor, which are final and binding.

1. Promotion Period: The Promotion begins on December 22, 2025, at 11:00 AM PST and concludes on February 4, 2026 at 9:00 PM PST (the "Promotion Period"). All entries must be submitted within the Promotion Period. Entries received after the end of the Promotion Period will be void.

2. How to Enter: Individuals will be automatically and contemporaneously entered in the Promotion each time during the Promotion Period that they visit any of the four Clark County, Nevada, locations of Carmine's Pizza Kitchen and purchase for on-premises dining or take-out dining any large size pizza with a menu price of \$20.99 or more as posted at <https://carminespizzakitchen.com/menu/> (a "Qualifying Purchase"). At the time of each Qualifying Purchase during the Promotion Period, the Sponsor will issue a two-part printed promotion entry ticket that is sequentially numbered on each part of a detachable ticket. One part of the sequentially numbered printed promotion entry ticket will be provided to the purchaser making the Qualifying Purchase and attached to the customer copy of the paper sale record receipt (the "Proof of Purchase"), and the other part of the sequentially numbered printed promotion entry ticket will be placed in a secure raffle drawing ticket drum at the Sponsor's location of the Qualifying Purchase (the "Qualifying Entry"). In case of dispute as to the identity of any entrant, each entry will be deemed made by the individual who produces for the Sponsor's inspection and duplication the customer copy of the paper sale record receipt with the attached sequentially numbered promotion entry ticket provided to the purchaser making the Qualifying Purchase (the "Authorized Promotion Entrant"). **ANY POTENTIAL WINNER MUST PROVIDE THE SPONSOR WITH PROOF THAT SUCH WINNER IS THE AUTHORIZED PROMOTION ENTRANT. RETAIN EACH OF YOUR PROOF OF PURCHASE FOR PRIZE VERIFICATION.**

3. Entry Limit and Exclusions. YOU CAN ENTER THE PROMOTION EVERY TIME YOU MAKE A QUALIFYING PURCHASE DURING THE PROMOTION PERIOD. LIMIT OF ONE PRIZE PER AUTHORIZED PROMOTION ENTRANT AS DETERMINED IN PARAGRAPH 6 OF THESE OFFICIAL RULES. PURCHASES MADE FOR DELIVERY ARE NOT ELIGIBLE FOR PARTICIPATION IN THE PROMOTION.

4. Information About Authorized Promotion Entrants: Information provided in connection with entrance into the Promotion will be used by Sponsor only for (i) accounting and recordkeeping of the Sponsor in the normal course of business; and (ii) administering the Promotion. By entering this Promotion, entrants give their express permission to be contacted by Sponsor for any purposes.

5. **Failed Entries; Disqualification:** Sponsor, including its directors, officers, employees, and agents, affiliates, and any third-party providers of services or goods are not responsible for incorrect or inaccurate entry information, an individual's failure to make each Qualifying Purchase in the name of the Authorized Promotion Entrant, any human mistake, technical error, point of sale system malfunctions, or for lost, late, misdirected, unintelligible, returned or undelivered entries, telephone calls, or emails, or for lost, interrupted or unavailable satellite, network, server, Internet Service Provider (ISP), website, or other connections availability, accessibility or for traffic congestion, miscommunications, failed computer, network, telephone, satellite or cable hardware or software or lines, or technical failure, or jumbled, scrambled, delayed or misdirected transmissions, computer hardware or software malfunctions, failures or difficulties, or other errors of any kind whether human, mechanical, electronic or network. Persons who tamper with or abuse any aspect of this Promotion, or act in violation of the Official Rules, or act in any manner to threaten, abuse or harass another entrant, as solely determined by Sponsor, may be disqualified in Sponsor's sole and absolute discretion. Entry materials that have been tampered with or altered are void.

6. **Winners Determination; Prize Notification and Delivery:** Subject to further verification and compliance with these Official Rules, the Prizes (defined below) will be awarded by the Sponsor from among Authorized Promotion Entrants who completed the entry process during the Promotion Period (the "**Winners**"). Winners will be selected by a drawing from among all the Qualifying Entries made at all four of the Sponsor's locations in Clark County, Nevada, utilizing a random selection from a raffle drawing ticket drum which will be conducted at Carmine's Pizza Kitchen located at 1395 Raiders Way, Henderson, Nevada 89052 (the "**Drawing Location**") between 6:00 p.m. and 7:00 p.m. (PST) on February 5, 2026. **AUTHORIZED PROMOTION ENTRANTS MUST BE PRESENT AT THE TIME OF SELECTION TO WIN. AN AUTHORIZED PROMOTION ENTRANT MAY WIN ONLY ONE PRIZE AS DETERMINED IN THE ORDER OF RANDOM SELECTION.**

To claim the applicable Prize the Winners must be present at the Drawing Location at the time of the drawing on February 5, 2026, and provide their (1) name; (2) mailing address; (3) verification that they are 18 years or older; and (4) Proof of Purchase corresponding to the winning tickets. No other party will be allowed to claim the Prize on the Winner's behalf. Authorized Promotion Entrants who are not present at the Drawing Location at the time of winner determination will forfeit and a new Winner will be selected by the Sponsor, in its sole and absolute discretion. The Winner will be required to provide identification and may be required to sign an affidavit acknowledging the award; the Prizes will only be awarded to a verified Winner. If a Winner refuses to execute the required documents or rejects their Prize, or in the event of noncompliance with these Official Rules, the Prize will be forfeited and a new Winner may be selected by the Sponsor, in its sole and absolute discretion.

Once the Winner's identity and eligibility are verified, the Prize will be paid by cashier's check made payable in the name of the Winner and delivered within ten (10) business days by Federal Express courier delivery signature required.

7. **Odds of Winning.** The odds of winning a Prize cannot be determined and is dependent upon total number of Qualifying Entries received. Winners may be required to supply Sponsor with a complete and valid IRS Form W-9.

8. **Change of Address Policy:** It is the sole responsibility of Winners to notify the Sponsor of any change in their contact information.

9. **Prizes:** Cash prizes in the amounts of \$25,000 (First Prize), \$15,000 (Second Prize) and \$10,000 (Third Prize), respectively, will be awarded by a random drawing conducted as provided in **Paragraph 6** of these Official Rules (the "**Prizes**"). All taxes and fees associated with using any Prize are the sole responsibility of each Winner. The Prizes are not transferable except at the sole discretion of Sponsor. In the sole discretion of Sponsor, the Prizes are subject to change without notice, but will be substituted with a alternative prize of equal or greater monetary value. The Prizes are awarded "as is" with no warranty or guarantee by Sponsor.

10. **Taxes:** ALL FEDERAL, STATE, AND LOCAL TAXES ASSOCIATED WITH THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. Winner will receive a 1099 tax form, when applicable, provided by Sponsor.

11. **Release:** By entering the Promotion, and to the extent allowed under applicable law, all entrants expressly agree to indemnify, defend, and hold harmless, and do hereby forever waive, release, discharge, and covenant not to sue Sponsor and their partners, owners, employees, members, assignees, successors, and managers and their respective members, managers, partners, owners, employees, agents, officers, directors, affiliates and shareholders (collectively "**Released Parties**"), for and from any and all claims, debts, liabilities, demands, obligations, costs, fees (including without limitation attorneys' fees), expenses, actions and causes of action whatsoever, of every nature, character and description (collectively, "**Claims**"), known and unknown, including, but not limited to, all those arising out of or in any way related to the Promotion; these Official Rules (including the legality of these Official Rules or any portion hereof); entrant's entry and/or eligibility in the Promotion; the negligence of Released Parties; any Prize (including without limitation the receipt, non-receipt, acceptance, rejection, possession, misuse or use of any Prize and any travel related to participation in the Promotion); any participation in the Promotion; and any presence at any Promotion-related or Prize-related venue (including without limitation any of the four locations of Carmine's Pizza Kitchen). Entrant represents and warrants that he or she owns and/or has the authority to release the Claims stated herein, and if applicable expressly waives Section 1542 of the California Civil Code, which provides: A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

12. **Trademarks:** The trademarks of Raiders Way LLC and Carmine's Pizza Kitchen are the property of the owners of such trademarks.

13. **Publicity; Use of Personal Information:** Except where prohibited by law, entrance into the Promotion grants Sponsor and its affiliates, agents, successors and assignees a royalty-free, fully paid, non-exclusive, sublicensable, transferable, irrevocable, perpetual, unrestricted, worldwide license to use, publish, transmit, display, store, distribute, your name, likeness, photograph, voice, biographical information, Prize information, hometown, and state for promotional purposes in any media whatsoever. Sponsor will not be required to pay any additional consideration or seek any additional approval in connection with such uses. Sponsor is not obligated to use any of the above-mentioned information, but may do so and may edit such information or materials, in Sponsor's sole discretion, without further notice, obligation or compensation, unless prohibited by law. Sponsor may require any Winner to execute a written consent containing this right of publicity.

14. **Entrant Acknowledgements; General Waivers; Waiver or Right to Class Action:** By entering this Promotion, entrants agree that (i) they have read and accepted these Official Rules; (ii) Sponsor may terminate, postpone or otherwise modify the Promotion at any time in its sole and absolute discretion

including, without limitation, in the event of equipment failure or malfunction, acts of God, natural causes, labor disputes, or fire, flood or other casualties; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Promotion, but in no event attorneys' fees; and, (iv) under no circumstances will any entrant be permitted to obtain any award for, and entrants hereby waive all rights to claim punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages other than actual out-of-pocket expenses. BY ENTERING THIS PROMOTION, EACH ENTRANT HEREBY WAIVES ANY RIGHT TO PROCEED BY WAY OF A CLASS ACTION, TO SERVE IN ANY REPRESENTATIVE CAPACITY FOR OTHERS, AND TO ACT AS A PRIVATE ATTORNEY GENERAL IN ANY CLAIM OR CONTROVERSY ARISING OUT OF OR RELATING TO THIS PROMOTION OR THE BREACH, TERMINATION, ENFORCEMENT, INTERPRETATION OR VALIDITY THEREOF. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies or certain kinds of damages, and so these limitations may not apply to you.

15. **Governing Law; Venue:** Except where prohibited, each entrant agrees that: (i) all issues and questions concerning these Official Rules shall be governed exclusively by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; (ii) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any Prize awarded shall be (A) resolved individually, without resort to any form of class action; and, (B) filed only in the state or federal courts situated in Clark County, Nevada, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and, (iv) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

16. **Severability:** The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
